Winnebago County Sheriff's Office:

Orders of Protection are served by the Winnebago County Sheriff's Department to respondents who live in Winnebago County. After seeing a judge, the Emergency Order of Protection paperwork will be entered into the system. The Sheriff's office will then be notified. This process may take some time to complete and your paperwork will not be in the system immediately after leaving the courthouse. Service to the respondent will be attempted as soon as possible. In the meantime, you may want to have a safety plan while everyone works to serve the Order of Protection.
