Position Summary

Under the direction of departmental leadership, the Juvenile Probation Intervention Officer is responsible for the facilitation, coordination, and development of evidence-based programs designed to reduce recidivism and address criminogenic needs of justice-involved youth. This position plays a key role in delivering cognitive behavioral interventions, supporting family engagement, coordinating community service programming, and assisting with the monitoring of youth placed on In-Home Confinement. The Intervention Officer also researches emerging best practices and assists with program development and implementation efforts.

Essential Duties and Responsibilities

- Facilitate evidence-based Cognitive Behavioral Programs for justice-involved youth.
- Facilitate Parent Orientation Groups with Senior Probation Officers.
- Research emerging trends, evidence-based practices, and innovations related to cognitive behavioral interventions and juvenile justice programming.
- Assist in drafting proposals and recommendations for departmental implementation of new or enhanced programs.
- Demonstrate comfort and competency in teaching, leading, and managing group-based programming with youth and adults.
- Assist with monitoring youth placed on In-Home Confinement, in coordination with assigned probation staff.
- Apply knowledge of best practices for addressing criminogenic needs, including working knowledge of the Risk, Needs, and Responsivity (RNR) model.
- Coordinate the Public Service Work (PSW) Program, ensuring compliance with court-ordered community service requirements.
- Develop, maintain, and strengthen partnerships with local community service worksites.
- Track, document, and report PSW participation and completion as required.
- Participate in required trainings, professional development, and ongoing education related to assigned duties.
- Perform other related duties as assigned to support departmental operations and program goals.

Knowledge, Skills, and Abilities

- Knowledge of juvenile justice principles and evidence-based practices.
- Understanding of cognitive behavioral interventions and criminogenic needs.
- Working knowledge of the Risk, Needs, and Responsivity (RNR) model.
- Familiarity with trauma-informed care, motivational interviewing and evidence-based practices is a plus.
- Strong group facilitation, presentation, and communication skills.
- Ability to engage youth and families from diverse backgrounds with professionalism, fairness and consistency
- Ability to develop community partnerships and maintain collaborative relationships.
- Strong organizational, documentation, and time-management skills.
- Ability to work both independently and as part of a multidisciplinary team.
- Bilingual (English/Spanish) preferred but not required.

Minimum Qualifications

- Bachelor's degree in Criminal Justice, Social Work, Psychology, Education, or a related field.
- Experience working with justice-involved youth, group facilitation, or community-based programming preferred.
- Must be a resident of the State of Illinois or approved exemption.
- Valid driver's license.
- Must pass pre-employment background check and wellness exam including drug screen.
- Must comply with all federal and state laws; to include prohibition of the consumption, possession, sale, purchase or delivery of cannabis or cannabis infused substances.
